

# 2019 Spanish & Portuguese Publishing Grant Program

## I. Organizer: Taipei Book Fair Foundation

## II. Main Purpose

In order to promote and encourage international publishers to translate and publish original Taiwanese publications, Taipei Book Fair Foundation has organized the Spanish & Portuguese Publishing Grant Program as a means of supporting the overseas titles sales of original Taiwanese publications.

## III. Applicant Eligibility

Foreign publishing houses or literary agencies (legal persons) legally registered in their respective countries in accordance to the law and regulations.

## IV. Grant Conditions

1. The applied publication should be an original Taiwanese publication created by Taiwanese authors or illustrators (R.O.C. nationality).
2. The copyright to translate and publish the publication into Spanish or Portuguese should be authorized by a Taiwanese publishing company or a Taiwanese author/ illustrator.
3. Verified projects are expected to be published by **November 20, 2021** (according to the publishing date on the copyrights page) in order to receive full funding. It shall be specified on the copyright page or other obvious parts of the book that the work is sponsored by Taipei Book Fair Foundation.

## V. Application Method

The application period is until **November 20, 2020**. Please apply online.

### Step 1. Fill out an Application Form

### Step 2. Provide a Digital Copy of the Signed Contract

Due to confidentiality concerns, please email the signed contract to [international@taipeibookfair.org](mailto:international@taipeibookfair.org) by November 20, 2020. Please include "2019 Spanish & Portuguese Publishing Grant Application: [Book Title](#)" in the subject line of the email. You may conceal the authorization fee if you prefer for it to remain confidential. An application is only considered to be complete and confirmed after TBFF has received both documents.

### Step 3. Verification

The Foundation will review the submitted documents. Considering the total pages of the book, the amount to be printed, and other conditions as proclaimed in the contract, TBFF will settle on a fixed subsidy amount.

#### **Step 4. Notification**

Within a month of receiving the application, TBFF will send a confirmation letter that confirms the application result and discloses the amount of project funding.

#### **Step 5. Posting**

After the translated book is published, please send us the following items:

Upon receiving the hard copies of the translated and published book(s), TBFF will provide the full amount of the subsidy within one month.
